Public Comments: There were ten community members that attended the May 13, 2025 board meeting. Presentations and discussions of the following:

Lori Tubergen-Clark – County Commissioner for District 5 presented the following information:

Newaygo County hired a new parks director, Asa Vermeulen, who is busy working on park expansion and educational programs. There was a deep candidate pool for this position.

Jail quarterly report indicates 249 beds occupied, 102 in county, 12 out of county and 135 federal inmates.

Secure Rural Schools Revenue which are usually available at this time are hung up at the federal level, county is watching to see what happens with the house bill 1383 these are attached to.

George Such said that Mrs. Tubergen-Clark was doing a wonderful job as the new District 5 County Commissioner.

Georgia Andres, City of Newaygo Chief of Police, Mitch Rood, Newaygo Public Schools Resource Officer and Ben Gilpin, Superintendent Newaygo Public Schools presented information on the contract for the School Resource Officer with Newaygo Public Schools. The contract will be presented at the June board meeting and they wanted to be here for the May 13, 2025 meeting to answer any questions.

Crime in Newaygo schools is down to 0 at this time, currently the coverage of two officers with a full-time officer at the middle school has shown a meaningful change in behaviors and a very good relationship with the student to officers.

NPS Superintendent indicated that day to day officer coverage has been a huge need and much needed in making critical decisions.

The contract is with the Newaygo Public School District and the City of Newaygo Police Department, with the townships of Garfield, Big Prairie, Brooks, Croton and City of Newaygo sharing in the funding of these positions.

Many of the community members asked questions regarding the service.

Solar Company and possible installation in Garfield Township – there was much discussion regarding solar energy activity in Garfield Township. Currently the Garfield Township Planning Committee is working on a Solar Ordinance. There is a public hearing for the draft solar ordinance for Solar Energy on May 27, 2025 at 7:00 pm, members in attendance were encouraged to attend.

Old Woman's Bend - community member brought up this subject followed by a short discussion.
